- 1. Open vial according to the enclosed instructions.
- 2. Using a single tube of #1877 broth (5 to 6 ml), withdraw approximately 0.5 ml to
- 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the pellet.
- 3. Aseptically transfer this aliquot back into the broth tube and mix well.
- 4. Use several drops of the cell suspension to inoculate a second tube of broth, a slant and/or a plate.
- 5. Incubate all tubes and plate at 26°C for 48 to 72 hours.

Notes

Colonies are bright orange in color with a rough dull surface.

Cells are pleomorphic rods and primary branching is observed.
