## ***Rhodococcus rhodochrous* (Zopf) Tsukamura emend. Rainey et al.**

1. Open vial according to the enclosed instructions.
  2. Using a single tube of #1877 broth (5 to 6 ml), withdraw approximately 0.5 ml to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the pellet.
  3. Aseptically transfer this aliquot back into the broth tube and mix well.
  4. Use several drops of the cell suspension to inoculate a second tube of broth, a slant and/or a plate.
  5. Incubate all tubes and plate at 26°C for 48 to 72 hours.

### **Notes**

Colonies are bright orange in color with a rough dull surface.

Cells are pleomorphic rods and primary branching is observed.
