Handling Procedures

1. Open vial according to enclosed instructions.
 2. Using a single tube of #3 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
 4. Use several drops of the suspension to inoculate an additional broth tube, a #3 agar slant and/or a plate.
 5. Incubate all tubes and plate at 30°C for 24 to 48 hours.

Notes

Colonies on #3 agar are pale cream to very light yellow, irregular, translucent, slightly lobate, slight convex center, dry, and dull..
