# Handling Procedures

- 1. Open vial.
- 2. From a single tube of #542 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the entire pellet.
- 3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well
- 4. Use several drops of this suspension to inoculate a second tube of broth, a slant and/or a plate.
- 5. Incubate tubes and plate at 37°C for 24-48 hours.
