## Handling Procedures

1. Open vial according to enclosed instructions.
  2. Using a single tube of #820 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate pellet.
  3. Aseptically transfer this aliquot back into the broth tube. Mix well.
  4. Use several drops of the suspension to inoculate a second tube of broth, a slant, and/or plate of #820 media.
  5. Incubate all tubes and plate at 30°C for 24 hours.

## Notes

On #820 plates two colony types are seen, a) 90% spreading and translucent; b) 10% entire, glistening, and smooth.
