- 1. Open vial according to enclosed instructions.
- Using a single tube of #878 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a #878 agar slant and/or plate.
- 5. Incubate the tubes and plate at  $37^{\circ}$ C for 48 hours in an atmosphere of 5% CO<sub>2</sub>. Loosen the screw caps during the incubation.

## Notes

Colonies on #878 plates are entire, glistening, circular, smooth, and raised.
