Handling Procedures

1. Open vial according to enclosed instructions.
 2. From a single tube of the recommended broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the pellet.
 3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.
 4. Heavily inoculate a slant of #90 and/or a #173 plate.
 5. After growth has been achieved, further transfers may be made.

Notes

Growth on solid medium may take three to five days. Colonies on #173 are cream, smooth, circular, entire, and convex.
