Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

1. Open vial according to enclosed instructions.

2. From a single tube of #44 broth (5 to 6 mL), withdraw approximately 0.5 to 1 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a #260 agar slant and/or plate.
5. Incubate all tubes and plate at 37°C for 24 to 48 hours.

Notes

Incubation in a 5% CO₂ environment may enhance growth.
