Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## Handling Procedures

1. Open vial according to enclosed instructions or visit [www.atcc.org](http://www.atcc.org) for instructions.
2. Rehydrate the entire pellet with approximately 0.5 mL of #4 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #4 broth. Additional test tubes

can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary broth tubes.

3. Use several drops of the primary broth tube to inoculate a #4 plate and/or #4 agar slant.
  4. Incubate at 35 - 37°C for 24 to 48 hours in an atmosphere of 5% CO<sub>2</sub>.

### **Notes**

This strain does not recover well with BHI medium. An atmosphere of 5% CO<sub>2</sub> is required for growth.
