Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

- 1. Open vial according to enclosed instructions.
- Using a single tube of #1395 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.

- 4. Use several drops of the suspension to inoculate a #173 and/or #90 agar slant and/or plate.
- 5. Incubate the tubes and plate at 37°C for at least 7 days.

Notes
