### **Handling Procedures**

1. Open vial according to enclosed instructions.
2. Using a single tube of #416 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate pellet.

3. Aseptically transfer this aliquot back into the broth tube. Mix well.
  4. Use several drops of the suspension to inoculate a second tube of broth, a slant, and/or plate.
  5. Incubate all tubes and plate at 26°C for 48 hours.

### **Notes**

On solid medium colonies are small, circular, convex and shiny. This organism has a yellow to off-white pigment. This strain will also grow on ATCC Medium #416, Lactobacilli MRS broth (Difco 0881).
