### Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. Using a single tube of #3 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a #3 agar slant and/or plate.



5. Incubate all tubes and plate at 37°C for 24 hours.

#### Notes

On #3 plates, colonies are entire, glistening, circular, smooth, and approximately 1.5 to 2 mm in diameter.
