Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #3 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a second tube of broth, a slant, and/or plate.

5. Incubate all tubes and plate at 37°C for 24 to 48 hours.

Notes

This strain requires proline for growth. To check this requirement, the organism is opened into a tube of #3 broth and a #3 plate streaked for isolation. After 24 hours, a small amount of a single colony is picked and a tube of minimal broth inoculated to produce a very light turbidity. A single drop of this suspension is passed into a second tube of minimal broth and a tube of minimal broth plus the required amino acid (L-proline used at 0.2 mg/ml). A tube of #3 broth is also inoculated with a single drop to assure enough cells were added for growth. After 24 and 48 hours incubation at 37°C, tubes are examined for growth. The tube without added amino acid should show no growth while the tubes with the added amino acid and the #3 broth should show turbidity.

On #3 plates, colonies are entire, glistening, circular, smooth, raised, and translucent. Additional information on this culture is available on the ATCC web site at www.atcc.org.
