Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #3 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0

- mL with a Pasteur or 1.0 mL pipette. Rehydrate pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
 4. Use several drops of the suspension to inoculate a second tube of broth, a slant, and/or plate.
 5. Incubate all tubes and plate at 37°C for 24 hours.

Notes

Colonies on #3 agar are circular, glistening, translucent and convex.

This strain exhibits alpha hemolysis on blood agar.

This strain was confirmed by PCR to not carry the *eae*, *stx1*, and *stx2* genes (*stx1*-, *stx2*-, *eae*-).
