Morphology: On PDA medium at 25°C after 7 days, mycelium white to creamy white becoming moss green as conidia develop, velutinous, exudes a yellow pigment into the media. Reverse cream to buff. Hyphae hyaline, guttulate. Conidiophores terverticulate. Phialides flask-shaped. Conidia moss green, globose, smooth, 3-4.5 X 3-4.5 μ m.
