## Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #192 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Incubate broth tube for 48 to 72 hours. After incubation, use several drops of

the suspension to inoculate agar slants and/or plates.

5. Incubate tubes and plates at 37°C. Five to seven days of incubation may be necessary to obtain visible growth on agar surfaces. Colonies are grayish, glistening, and opaque. Subsequent transfers require 48 to 72 hours incubation.
