Handling Procedures

1. Open vial according to the enclosed instructions.
2. Using a single tube of 518 broth (5 to 6 ml), withdraw approximately 0.5 ml to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube and mix well.

4. Use several drops of the cell suspension to inoculate a second tube of broth, a slant and/or a plate.

5. Incubate all tubes and plate at 30°C for 2-10 days.

Notes

Colonies on #518 agar are yellow orange rounded with irregular edges partially growing under the agar surface.
