ATCC Medium 18: Trypticase Soy Agar/Broth

**Temperature:** 37°C

**Atmosphere:** Aerobic

## Handling Procedures

1. Open vial.
2. Using a single tube of #18 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a #18 agar slant and/or plate.
5. Incubate the tubes and plate a 37°C for 24 to 48 hours.

## Notes

Colonies on #18 agar at 24-48 hrs. are <5 mm, mucoid opaque, butyrous, convex, cream colored, circular, and entire. No hemolysis appears on blood agar plates. The cells are large, straight, Gram positive rods, medium to long in length, in singles and short chains, with subterminal spores and are motile. Older cultures may strain Gram variable.
