Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Growth Conditions

Medium:

Anaerobe Systems Brucella Blood Agar Plates (BRU) (AS-111 or AS-141)

ATCC Medium 2722: Supplemented Tryptic Soy Broth/Agar

ATCC Medium 260: Trypticase soy agar/broth with defibrinated sheep blood

Temperature: 37°C

Atmosphere: Anaerobic

Handling Procedures

1. Open vial according to enclosed instructions or visit www.atcc.org for instructions.
2. Under anaerobic conditions aseptically rehydrate the entire pellet with

approximately 0.5 mL of #2722 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #2722 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary broth tubes. Best practice dictates the use of pre-reduced media.

3. Use several drops of the primary broth tube to inoculate a brucella plate and/or #260 agar slant.
4. Incubate in an anaerobic atmosphere at 37°C for 5-7 days. Incubate one agar plate aerobically at 37°C to check for contamination.

ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by the use of an anaerobic gas chamber or placement of test tubes under a gassing cannula system connected to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in an anaerobic chamber
- Loose screw caps on test tubes in an activated anaerobic gas pack jar
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained

Notes

Anaerobe Systems Brucella Blood Agar (AS-111 or AS-141) can be used to analyze colony morphology and purity.

When examined microscopically, the cells appear as large rods often in pairs or chains. Motility was not detected. No growth occurred on the non-selective media.

Always use freshly prepared anaerobic medium. If there is any question about the anaerobic condition of the medium, the medium can be reduced with the addition of 1.5% cysteine (2.0 mL per 100 mL of medium). Other commonly used reducing agents are sodium sulfide, cysteine, dithiothreitol, and titanium citrate.
