### **Handling Procedures**

1. Open vial.
2. From a single tube of #416 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0

- ml with a Pasteur or 1.0 ml pipette and use to rehydrate the entire pellet.  
Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.
3. Use several drops of this suspension to inoculate a second tube of #416 broth, a #416 slant and/or a #416 plate.
  4. Incubate at 37°C in 5% CO<sub>2</sub> for 24 hours.
