#### Handling Procedures

- 1. Open vial according to enclosed instructions.
- Using a single tube of #1877 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a #196 agar slant and/or plate.

5. Incubate the tubes and plate at 26°C for 5 to 7 days.

#### Notes

This item may require growth to be established in broth tubes for 5 to 7 days before culturing on agar plates.
