Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

- 1. Open vial according to enclosed instructions or visit www.atcc.org for instructions.
- 2. Rehydrate the entire pellet using approximately 0.5 mL of #3 broth. Aseptically transfer the entire contents to a tube of 5-6 mL #3 broth. Additional broth tubes can be inoculated by transferring 0.5 mL from this primary broth tube to secondary broth tubes.

- 3. Use several drops of the primary broth to inoculate a #3 plate and/or slant.
- 4. Incubate all tubes and plate at 37°C for 24 hours.

Notes

Referred to as the type strain (J. Bacteriol. 4: 429-503, 1919). However this is not one of the strains on which Morgan based his original description of this organism, hence it cannot be designated as the type.
