Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

- 1. Open vial according to enclosed instructions or visit www.atcc.org for instructions.
- 2. Rehydrate the entire pellet with approximately 0.5 mL of #546 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #546 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary broth tubes.

- 3. Use several drops of the primary broth tube to inoculate a #546 plate and/or #546 agar slant.
- 4. Incubate at 37°C for 72 hours in an atmosphere of 5% CO₂.

Notes

May have better growth on ATCC Medium #814: GC Agar or ATCC Medium #260: Trypticase Soy Agar/Broth with 5% Sheep Blood (defibrinated). Growth occurs in ATCC Medium #814: GC broth.
