## Handling Procedures

#### 1. Open vial according to enclosed instructions.

2. Under anaerobic conditions, withdraw 0.5 ml of the

recommended broth from a single test tube (5 to 6 ml) and rehydrate the vial contents.

Additional tubes of broth may be inoculated with 0.5 ml each from the suspension, and 0.1 ml may be inoculated onto a slant. Streak several blood plates to check for colonial morphology and purity.

Incubate one agar plate anaerobically and one in 5% CO<sub>2</sub>.

5. Within 72 hours, growth is evident by turbidity and

smooth sediment in the broth and by colonies on the agar surfaces. On #260 agar, colonies are small, circular, entire, convex, and transparent. Colonies are very small on plates incubated in 5% CO<sub>2</sub>.

#### ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

- · Use of an anaerobic gas chamber, or
- $\cdot \ Placement \ of \ test \ tubes \ under \ a \ gassing \ cannula \ system \ hooked \ to \ anaerobic \ gas.$

Anaerobic conditions for incubation may be obtained by any of the following:

- · Loose screw caps on test tubes in anaerobic chamber,
- · Loose screw caps on test tubes in an activated anaerobic gas pack jar, or
- $\cdot$  Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.
