Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

- Aseptically transfer the entire contents to a 5-6 mL tube of #1395 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.
3. Use several drops of the primary broth tube to inoculate a #173 plate and/or #90 agar slant.
  4. Incubate at 37°C for 4 to 7 days.
