Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

#### **Growth Conditions**

Medium: ATCC Medium 7: Actinomyces broth Temperature: 37°C Atmosphere: 5-10% CO<sub>2</sub>; Anaerobic

#### Handling Procedures

**1**. Open vial according to enclosed instructions.

2. Using a single tube of #7 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.

3. Aseptically transfer this aliquot back into the broth tube. Mix well.

4. Use several drops of the suspension to inoculate a #7 agar slant and/or plate.

5. Incubate the tubes and plate under 5-10%  $\rm CO_2$  or anaerobically at 37°C for 48 to 72 hours.

ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

 $\cdot$  Use of an anaerobic gas chamber, or

· Placement of test tubes under a gassing cannula system hooked to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

· Loose screw caps on test tubes in anaerobic chamber,

 $\cdot$  Loose screw caps on test tubes in an activated anaerobic gas pack jar, or

 $\cdot$  Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.

#### Notes

Colonies on #7 agar are white, round and convex. Best growth occurs when culture is incubated in 5-10% CO2. This strain produces both  $\alpha$  and  $\beta$  hemolysis depending on the media and incubation conditions. Many of the cells are club shaped but no refractile bodies are apparent.
