Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. Using a single tube of #51 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth. Additional tubes may be inoculated with 0.5 mL each from the suspension. Also, 0.1 mL may be inoculated onto a slant. Streak several blood plates to check for colonial morphology and purity.
- 4. Incubate tubes under an anaerobic atmosphere at 37°C for 24-48 hours. Incubate one agar plate anaerobically for colony formation and one aerobically for aerobic contamination check.

ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

- Use of an anaerobic gas chamber, or
- Placement of test tubes under a gassing cannula system connected to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in anaerobic chamber,
- Loose screw caps on test tubes in an activated anaerobic gas pack jar, or
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.

Notes

The presence of cpa and pfoA genes was confirmed by PCR.
