### **Handling Procedures**

1. Open vial according to enclosed instructions.
2. Using a single tube of #615 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.

3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a #615 slant, and/or plate
5. Incubate all tubes and plates at 37°C for 24 hours.
6. After growth has been achieved, transfers may be made to secondary tubes of broth, slants, and /or plates.

### **Notes**

Colonies on #615 plates are entire, glistening, circular, smooth, raised, and translucent.
