Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #2714 broth (5 to 6 mL), withdraw approximately 0.5 to

- 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
 4. Use several drops of the suspension to inoculate a #2721 agar slant and/or plate.
 5. Incubate the tubes and plate at 37°C for 4 weeks.

Notes

With the 40 mM solution of sodium pyruvate added to the media formulation, there should be abundant growth as specified in the reference (Keating LA, *et al.* Mol Microbiol 56(1): 163-174, 2005). Without the sodium pyruvate added to the Middlebrook formulation, there will be some growth, but it may be poor.
