#### Handling Procedures

- 1. Open vial.
- Rehydrate the entire pellet with approximately 0.5 mL of # 416 broth.
  Aseptically transfer the entire contents to a 5-6 mL tube of # 416 broth.
  Additional test tubes can be inoculated by transferring 0.5 mL of the primary

broth tube to these secondary tubes.

- 3. Use several drops of the primary broth tube to inoculate a # 416 plate and/or #416 agar slant.
- 4. Incubate at 30°C for 24-48 hours.
