### **Medium:**

ATCC Medium 416: Lactobacilli MRS Agar/Broth

**Temperature:** 30°C

**Atmosphere:** Aerobic

## **Handling Procedures**

1. Open vial.
2. Rehydrate the entire pellet with approximately 0.5 mL of # 416 broth.  
Aseptically transfer the entire contents to a 5-6 mL tube of # 416 broth.  
Additional test tubes can be inoculated by transferring 0.5 mL of the primary

broth tube to these secondary tubes.

3. Use several drops of the primary broth tube to inoculate a # 416 plate and/or #416 agar slant.
4. Incubate at 30°C for 24-48 hours.

Growth may need to be established in broth before attempting growth on agar.
