## Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #18 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a second tube of broth, a slant, and/or plate.

5. Incubate all tubes and plate at 37°C for 24-48 hours.

## Notes

Two colony types are observed on #18 agar plates: A) Entire, glistening, smooth, convex, circular, translucent, non-diffusing yellow-green pigment. B) Umbonate, spreading, irregular, glossy, translucent, non-diffusing yellow-green pigment. This strain has a grape smell and is  $\beta$ -hemolytic.
