## Handling Procedures

1. Open vial according to enclosed instructions.
2. Under anaerobic conditions, withdraw 0.5 ml of #1053 from a single test tube (5 to 6 ml) and rehydrate the entire vial contents.

**3. Aseptically transfer this aliquot back into the broth tube. Additional tubes may be inoculated with 0.5 ml each from the suspension and 0.2 ml for slants. Streak several blood plates to check for colonial morphology and purity.**

**4. Incubate tubes under anaerobic conditions at 37°C. Incubate one plate anaerobically for colony formation, and one aerobically for aerobic contamination check.**

5. After 1-2 days, growth is evident by good turbidity in the broth and colonies on the agar slant. The aerobic plate may have a thin film in the area of heaviest inoculation, however it should show no other signs of aerobic contamination.

#### ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

- Use of an anaerobic gas chamber, or
- Placement of test tubes under a gassing cannula system hooked to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in anaerobic chamber,
- Loose screw caps on test tubes in an activated anaerobic gas pack jar, or
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.

## Notes

Colonies after 24 hours are pinpoint, circular, entire, convex, smooth, glistening, and translucent.
