## Handling Procedures

1. Open vial according to enclosed instructions.
2. From a single tube of #18 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette and use to rehydrate the pellet.
3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.
4. Use several drops of this suspension to inoculate an additional broth tube, a #18 agar slant and/or a plate.

5. Incubate the tubes and plate at 37°C for 24 hours.

## Notes

On #18 plates, colonies are entire, glistening, circular, and smooth. This strain is the recommended host strain for *Staphylococcus aureus* bacteriophage 83A, ATCC® 27706-B1™. It produces coagulase.
