Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

#### Medium:

ATCC Medium 1589: Modified chopped meat medium (ATCC medium 1490) with 1%

glucose

ATCC Medium 260: Trypticase soy agar/broth with defibrinated sheep blood

**Temperature:** 37°C **Atmosphere:** Anaerobic

### Handling Procedures

1. Open vial according to enclosed instructions or visit www.atcc.org for instructions.

- 2. Under anaerobic conditions, aseptically rehydrate the entire pellet with approximately 0.5 mL of #1589 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #1589 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary broth tubes. Best practice dictates the use of pre-reduced media.
- 3. Use several drops of the primary broth tube to inoculate a Brucella blood agar plate and/or #260 agar slant.
- 4. Incubate in an anaerobic atmosphere at 37°C for 24-48hours. Incubate one agar plate aerobically at 37°C to check for contamination.

#### ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by the use of an anaerobic gas chamber or placement of test tubes under a gassing cannula system connected to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in an anaerobic chamber
- Loose screw caps on test tubes in an activated anaerobic gas pack jar
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained

#### Notes

Anaerobe Systems® Brucella Blood Plate (AS111 or AS141) can be used to analyze colony morphology and purity.
