Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## **Handling Procedures**

1. Open vial according to enclosed instructions or visit [www.atcc.org](http://www.atcc.org) for instructions.
2. Rehydrate the entire pellet with approximately 0.5 mL of #416 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #416 broth.

Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary broth tubes.

3. Use several drops of the primary broth tube to inoculate a #416 plate and/or #416 agar slant.
4. Incubate at 30°C for 3 to 5 days in an atmosphere of 5% CO<sub>2</sub>.

### **Notes**

After 48 hours, growth will be evident by turbidity in the broth and the formation of small colonies on the slant and/or plate. Growth is best in broth culture or on biphasic slants. Only scant growth is observed on agar.
