Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submerged in liquid nitrogen.

### **Handling Procedures**

1. Open vial according to enclosed instructions.
  2. Using a single tube of #948 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
  3. Aseptically transfer this aliquot back into the broth tube. Mix well.
  4. Use several drops of the suspension to inoculate a #948 agar slant and/or plate.
  5. Incubate the tubes and plate at 30°C for 48 hours.

### **Notes**

After approximately 48 hours of incubation at 30°C, growth is observed by turbidity in the broth tube.
