Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

1. Open vial according to enclosed instructions.
- 2. Using a single tube of #948 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.**
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.**
- 4. Use several drops of the suspension to inoculate a #948 agar slant and/or plate.**

5. Incubate the tubes and plate at 30°C for 24-48 hours.
