Neisseria elongata subsp. *glycolytica* strain 6171/75 [NCTC 11050] is a whole-genome sequenced bacterial type strain that was isolated from a throat swab. This strain is grown under a 5% CO₂ atmosphere on GC medium.

Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

2. Aseptically transfer the entire contents to a 5-6 mL tube of #814 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.
 3. Use several drops of the primary broth tube to inoculate a #814 plate and/or #814 agar slant.
 4. Incubate at 37°C for 2-3 days in an atmosphere of 5% CO₂.

Notes

Brain Heart Infusion (BD 237500) can be used to rehydrate vial contents if #814 broth is not available, but it will not support growth as well as the GC broth.
