Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submerged in liquid nitrogen.

## Handling Procedures

1. Open vial according to enclosed instructions.
2. From a single tube of #172 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the pellet.
3. Transfer the rehydrated pellet back into the broth tube. Mix well.
4. Use several drops of this suspension to inoculate a second tube of broth, a slant

and/or a plate.

5. Incubate all tubes and plates at 26°C for 7 to 14 days

Growth is brown in color with no sporulation observed. A brown diffusible pigment is formed.
