Description

Escherichia coli strain CDC 3250-76 was isolated from the feces of a human male infant. This enteroadherent *E. coli* (EAEC) strain is a whole-genome sequenced product and confirmed by PCR to carry the CVD432 and *aggR* genes. Serotype is O111a,111b:K58:H21.

Handling Procedures

1. Open vial according to enclosed instructions.
 2. Using a single tube of #3 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
 4. Use several drops of the suspension to inoculate a second tube of broth, a slant, and/or plate.
 5. Incubate all tubes and plate at 37°C for 24 hours.

Notes

This strain was confirmed by PCR to not carry the *eae*, *stx1*, and *stx2* genes (*stx1*-, *stx2*-, *eae*-).
