Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.

- 4. Use several drops of the primary broth tube to inoculate a #2 plate and/or #2 agar slant.
- 5. Incubate at 22°C for 72 hours.
