## Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #1395 or #44 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.

3. Aseptically transfer this aliquot back into the broth tube. Mix well.
  4. Use several drops of the suspension to inoculate a #90 or #44 agar slant and/or plate.
  5. Incubate the tubes and plate at 37°C for 3-5 days.

### **Notes**

Two colony types observed on #44 agar are a) irregular, flat, dull, rough, translucent, and slightly undulate; b) circular, pulvinate, smooth, dull, opaque, and entire. Both types are light orange.

Two colony types observed on #90 agar are a) rough, wrinkled, dull, and light to dark orange; b) light orange, smooth-rough, dull, and pulvinate.
