### **Handling Procedures**

1. Open thawed vial.
  2. Aseptically transfer the entire contents to a 5-6 mL tube of #3 broth.  
Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.
  3. Use several drops of the primary broth tube to inoculate a #3 plate and/or #3 agar slant.
  4. Incubate at 37°C for 24 hours.
