Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## Handling Procedures

1. Open vial according to enclosed instructions.
2. From a single tube of #416 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette and use to rehydrate the pellet.
3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well

4. Use several drops of this suspension to inoculate a second tube of broth, a slant and/or a plate.
  5. Incubate tubes and plate at 37°C for 24-48 hours in an atmosphere of 5% CO<sub>2</sub>. Loosen the screw caps of tubes while incubation period.
