ATCC Medium 2: Marine agar 2216 or marine broth 2216

**Temperature:** 30°C

## Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #2 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a #2 agar slant and/or plate.

5. Incubate the tubes and plate at 30°C for 24 hours.

## Notes

Colonies on #2 agar are smooth, entire, mucoid, and glistening with dark striations with some segments clear. Cells are motile, slightly curved, some swollen, rods occurring singly, in pairs or in clumps with one, two or three polar flagella.
