Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #998 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Incubate the broth tube immediately for one to three days at 26°C.

5. Transfers can now be made to other tubes of broth, slants, and/or plates.
