ATCC Medium 260: Trypticase soy agar/broth with defibrinated sheep blood

Temperature: 37°C

Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. From a single tube of #44 broth (5 to 6 ml), withdraw approximately 0.5 to 1 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a #260 agar slant and/or plate.



5. Incubate all tubes and plate at 37°C for 24 to 48 hours.

Notes

If growth does not appear on primary agar plate or slants, transfer again from the 48 hour broth culture.

Colonies are entire, glistening, smooth, circular, and slightly opaque.
