## **Handling Procedures**

1. Open vial according to enclosed instructions or visit [www.atcc.org](http://www.atcc.org) for instructions.
2. Rehydrate the entire pellet with approximately 0.5 mL of #1018 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #1018 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary

broth tube to these secondary tubes.

3. Use several drops of the primary broth tube to inoculate a #1018 plate and/or #1018 agar slant.
4. Incubate at 30°C for 48 hours.
