Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## Handling Procedures

1. Immediately prior to working with the culture, place the frozen vial at room temperature to thaw.
2. Aseptically transfer the entire contents of the vial into a single broth tube (5 to 6 mL) of the recommended broth. Mix well. A slant and a pre-reduced blood plate may also be inoculated with 0.1 mL each of the cell suspension. An

aerobic blood plate may also be streaked to check for purity.

3. Incubate the tubes and plate under anaerobic conditions at 37°C. Incubate one blood plate aerobically at 37°C.
4. Within 48 hours, growth should be evident by turbidity in the broth. On agar surfaces, colonies are small, circular, glistening, low convex, and gray. No growth should occur on the blood agar plate incubated aerobically.

#### ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

- Use of an anaerobic gas chamber.
- Placement of test tubes under a gassing cannula system hooked to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in anaerobic chamber.
- Loose screw caps on test tubes in an activated anaerobic gas pack jar.
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.

## Notes

Anaerobe Systems Chopped Meat with Carbohydrate (CMC) (AS-823) medium may also be used for propagation.

Colonies on Brucella agar are small, entire, glistening, circular, smooth, low convex, and dull white.

Always use freshly prepared pre-reduced media or pre-reduced media that has been previously prepared but stored under anaerobic conditions. Resazurin in the media is a color indicator for anaerobic conditions. Observance of pink color in medium before use or during incubation shows anaerobic conditions have not been met and oxidation has occurred. Medium should be discarded.
